Extract of Article of Association, Greater China Photographic Society Ltd
Members

3. The Society shall have membership classified as follows :-
- (a) Founding Members (創會會員) – They are (i) persons who are subscribers to the M&A and (ii) Members who are recommended by the Permanent President before the second anniversary of the incorporation of the Society (or such longer time as the Board of Directors may extend) and approved by the Board of Directors to become a Founding Member of the Society. All Founding Members have voting rights at all General Meetings.
 - (b) Ordinary Members (普通會員) – They are persons of any nationality or sex, aged 18 years and above, who support the objects of the Society admitted to be Ordinary Members with the approval of the Board of Directors. Ordinary Members have NO VOTING RIGHT at the General Meetings.
 - (c) Voting Members (資深會員) – They are Ordinary Members recommended by the Permanent President and approved by the Board of Directors to be Voting Members. Voting Members are entitled to vote at all General Meetings.
 - (d) Young Members (青年會員) – persons of any nationality or sex, aged between 7 years and 18 years are eligible to be admitted as Young Members of the Society if his parent or guardian *ad litem* is an Ordinary Member of the Society. Admission of Young Members shall be subject to the approval of the Board of Directors.
 - (e) Honorary Members (名譽會員) – The Society may from time to time admit persons to be Honorary Members according to the provisions of these Articles. Honorary Members are NOT MEMBERS of the Society for all purposes of the Ordinance and the M&A of the Society.
 - (f) Affiliate Members (附屬會員) – Subject to approval by General Meeting, the Society may from time to time by agreement with any other association or society of photography extend the ordinary membership of the Society to the members of that other association or society. Admission of Affiliate Member is subject to approval of the Board of Directors. Persons to whom ordinary membership of the Society have been extended are called "Affiliate Members". Affiliate Members are not entitled to receive notice of any meetings nor to attend or vote at any meetings of the Society.
 - (g) Trade Members (商務會員) – business firms or companies that has sponsored or agreed to sponsor the functions and activities of the Society may be invited by the Permanent President to be a "Trade Members" of the Society for such period of time as the Permanent President may decide. Trade Members are NOT MEMBERS of the Society for all purposes of the Ordinance and the M&A.

Nothing in this Article shall prevent an Honorary Member to apply and hold other type of membership of the Society at the same time.

4. Except otherwise provided in these Articles and subject to the specific provisions on voting rights, all Members of the Society are entitled to receive notice of General Meetings and to attend the same.
5. The number of members with which the Society proposes to be registered is 50,000, but the directors may from time to time register an increase of members.

Honorary Members

6. Honorary Members of the Society shall consist of the following categories :-
 - (a) Honorary Patron (名譽贊助人) – a person who, in the opinion of the Permanent President, has a distinguished social standing and is supporting the purposes of the Society may be invited by the Permanent President to be the Honorary Patron of the Society. The tenure of the Honorary Patron shall be permanent until he tenders his resignation.
 - (b) Honorary President (名譽會長) – a person who, in the opinion of the Permanent President, has a good social standing and is supporting the purposes of the Society may be invited by the Permanent President to be the Honorary President of the Society. The tenure of the Honorary President shall be permanent until he tenders his resignation or until the title is forfeited by the Board of Directors by special majority votes of three-fourth (3/4th) of those present and voting on the proposed resolution.
 - (c) Emeritus President (榮譽會長) – all past Presidents and Vice Presidents shall be Emeritus Presidents of the Society. With the exception of Permanent President, the tenure of an Emeritus President shall be permanent until he tenders his resignation or until the title is forfeited by the Board of Directors by special majority votes of three-fourth (3/4th) of those present and voting on the proposed resolution.
 - (d) Honorary Adviser (名譽顧問) – a person who, in the opinion of the Permanent President, has rendered distinguished services to the Society or has displayed distinguished ability or originality in any branches of photography or its related arts or sciences may be invited by the Permanent President to be an Honorary Adviser of the Society for fixed term of one year renewable annually automatically until his resignation or until the termination by the Board of Directors, whichever is the earlier.
 - (e) Honorary Legal Adviser (名譽法律顧問) – person or firm who are willing to provide free legal advice or services to the Society may be retained by the Permanent President to be the Honorary Legal Adviser of the Society for a fixed term of one year renewable annually automatically until their resignation or until the termination by the Board of Directors, whichever is the earlier.
 - (f) Honorary Auditor (名譽核數師) – person or firm who are willing to provide free accountancy and auditing advice or services to the Society may be retained by the Permanent President to be the Honorary Auditor of the Society for a fixed term of one year renewable annually automatically until their resignation or until the termination by the Board of Directors, whichever is the earlier.
7. All Members shall abide by the provisions of the M&A of the Society and the resolutions passed by the Board of Directors and the decisions of the Permanent President made according to the express powers conferred by these Articles.

Membership Fees

- 8.a The admission fee for each Ordinary Member and Young Member shall be HK\$50.00 or such other sum decided by the Board of Directors from time to time. The annual membership fee for each Ordinary Member and Young Member shall be HK\$100.00. Life subscription for Ordinary Member should be HK\$1,000. The rate of annual membership fees may be altered from time to time by General Meeting upon recommendation of the Board of Directors.
- 8.b Admission fee for Voting Member shall be HK\$10,000.00. Annual membership fee for Voting Member shall be HK\$5,000.00 or such other rate as may be decided by the Permanent President from time to time. Admission fee and annual membership fee already paid during the period of his holding other type of membership may be used to set off to the extent of the same amount. Life Subscription for Voting Member should be HK\$50,000.-
- 9.a Admission fee is payable upon admission. Annual membership fee shall be payable in advance on the 1st day of each calendar year. Membership fee for a full calendar year shall be payable upon admission as Member irrespective of the date of admission during the year.
- 9.b Affiliate Members are exempted from admission fee and annual membership fee. When the services and facilities provided by the Society are limited, priority shall be accorded to the members of the Society over the Affiliate Members.

Retirement and Disqualification of Member

10. Any Member may resign or terminate his membership by giving written notice to the Board of Directors and in this case no subscription or admission fee is refundable. The notice shall take effect upon the actual receipt of the notice by the Society or such later date as specified in the notice.
11. The Board of Directors may forfeit the membership of any Member for one or more of the following reasons :-
 - (a) the Member has failed to pay his admission fee or annual membership fee for more than 2 months after due and payable.
 - (b) the Member is an undischarged bankrupt or a discharged bankrupt without paying in full all its bankruptcy debts.
 - (c) the Member has been convicted of any indictable offence and decided by the Board of Directors, at their sole opinion, to be unsuitable to be a member of the Society.
12. The Board of Directors may forfeit the membership of any Member at any time without assigning any reason by resolution passed by a majority of not less than three-fourth (3/4th) in number of all serving members of the Board of Directors.
13. Upon forfeiture of membership all rights and privileges of the Member pertaining to his membership shall be forfeited to the Society for the common benefit of all other subsisting Members according to the M&A.
